	historical or cultural significance in a neighbourhood.	
C (Contextual)	The site represents a building that contributes to the historic character of an area or streetscape, usually found in	
	groupings of more than one building, but may also be of individual importance.	
UA (Unassigned)	The site has yet to be officially evaluated.
